TERMS AND CONDITIONS

- 1. Payment of fees
- 1.1 Course fees must be paid in full before the start of the course.
- 1.2 The student is fully responsible for the payment of fees.
- 1.3 Examination results and certificates will be withheld until outstanding accounts are settled.
- 1.4 An additional hourly rate is charged for catch-up classes.
- 1.5 Private tuition for individuals and small groups is available at an additional fee.
- 1.6 Students are required to provide proof of payment using surname, initials and cell phone number as a reference.
- 1.7 Course fees include tuition, registration, the certificate fee, course material and one outing. Students are liable for the cost of stationery, transport, food and additional outings.
- 2. Cancellation, deferral and refund policies
- 2.1 Students who receive an acceptance letter may not cancel their enrolment for the course.
- 2.2 Students can apply to defer to a later course if the application is submitted two weeks before the start date.
- 2.3 Students must complete the course for which they have enrolled within 12 months of registering.
- 2.4 Students may be liable for an additional charge for deferrals.
- 2.5 No refunds will be granted to students who do not attend a course for which they have paid.

3. Registration policy

- 3.1 The completed registration form must be submitted with the following documents:
 - a copy of the student's passport/ID
 - a copy of the sponsor's passport (the person responsible for payment)
 - proof of payment.
- 3.2 EFL students will be required to complete a pre-assessment to determine their proficiency level before the start of the course.
- 3.3 Non-attendance of classes will not result in a reduction of course fees.
- 3.4 Students require special permission to transfer from one course to another.
- 3.5 Registration for a course cannot be transferred from one student to another.

4. Enrolment policy

- 4.1 Students are required to attend a minimum of 85% of the course to qualify for an attendance certificate.
- 4.2 Students are required to obtain an overall average of 60% for oral and written assessments to qualify for a certificate of completion.
- 4.3 Students agree to abide by the assessment criteria for each course.
- 4.4 Students agree to adhere to the University of Pretoria's policies and procedures.
- 4.5 Students agree to abide by the University of Pretoria's code of conduct for students.
- 4.6 Students confirm that they will not commit any form of plagiarism presenting the ideas or work of others as their own.
